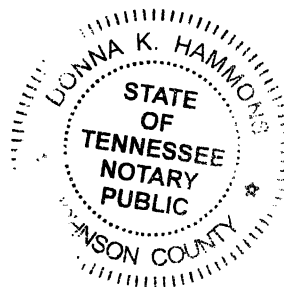

DEBARMENT CERTIFICATION
