GENERAL

CONTRACT TIME AND LIQUIDATED DAMAGES:

(7-1-95) (Rev. 12-18-07)

The date of availability for this contract is October 29, 2012.

The completion date for this contract is June 7, 2013.

Except where otherwise provided by the contract, observation periods required by the contract will not be a part of the work to be completed by the completion date and/or intermediate contract times stated in the contract. The acceptable completion of the observation periods that extend beyond the final completion date shall be a part of the work covered by the performance and payment bonds.

The liquidated damages for this contract are Eight Hundred Dollars (\$800.00) per calendar day.

The Contractor shall complete the required work of installing, maintaining, and removing the traffic control devices for lane closures and restoring traffic to the existing traffic pattern. The Contractor shall not close or narrow a lane of traffic on MAPS #1 and #8 during the following time restrictions:

DAY AND TIME RESTRICTIONS

Monday through Friday 6:00 a.m. to 9:00 a.m. Monday through Friday 4:00 p.m. to 7:00 p.m.

In addition, the Contractor shall not close or narrow a lane of traffic on ANY MAP, detain and/or alter the traffic flow on or during holidays, holiday weekends, special events, or any other time when traffic is unusually heavy, including the following schedules:

HOLIDAY AND HOLIDAY WEEKEND LANE CLOSURE RESTRICTIONS

- 1. For **unexpected occurrence** that creates unusually high traffic volumes, as directed by the Engineer.
- 2. For New Year's Day, between the hours of 6:00 a.m. December 31st and 7:00 p.m. January 2nd. If New Year's Day is on a Friday, Saturday, Sunday or Monday, then until 7:00 p.m. the following Tuesday.
- 3. For Easter, between the hours of 6:00 a.m. Thursday and 7:00 p.m. Monday.
- 4. For Memorial Day, between the hours of 6:00 a.m. Friday and 7:00 p.m. Tuesday.
