

Except where otherwise provided by the contract, observation periods required by the contract will not be a part of the work to be completed by the completion date and/or intermediate contract times stated in the contract. The acceptable completion of the observation periods that extend beyond the final completion date shall be a part of the work covered by the performance and payment bonds.

The liquidated damages for this contract are **Eight Hundred Dollars (\$800.00)** per calendar day.

Upon completion of the paving operation, backfill the trench to the satisfaction of the Engineer. Any excess material deposited on the shoulder shall be left in place and will be disposed of by State Forces.

No direct payment will be made for trenching, sawing, and removal of driveways, depositing material on shoulder area or backfilling trench, as the cost of this work shall be included in the bid unit price per ton for *Asphalt Concrete Base Course, Type ____*.
