PROJECT SPECIAL PROVISIONS Utility Construction

All proposed utility construction shall meet the applicable requirements of the NC Department of Transportation's Standard Specifications for Roads and Structures dated January 2012.

Revise the 2012 Standard Specifications as follows:

Utility Owners' Contact Information:

Page 15-1, Subarticle 1500-2 Cooperation with the Utility Owner, paragraph 2, add the following sentences:

Water lines on this project belong to Johnston County.

The Contractor shall provide access for the owner's representatives to all phases of construction and keep all valves and meters accessible during construction. A preconstruction meeting shall be held with Johnston County, the Utility Contractor and D.O.T. prior to any work beginning. The Contractor shall notify the owner two weeks before commencement of any work and three weeks before service interruption.

The proposed utility construction shall meet the applicable requirements:

Measurement and payment for the work shall be in accordance with NCDOT's "Standard Specifications for Roads and Structures"

The contractor shall provide a set of as-built plans to Johnston County after all the work shown on the Utility Construction Plans is completed.

Water Line Testing

Page 15-6; Subarticle 1510-3 (B) Testing and Sterilization, change the allowable leakage formula to:

W=LD√**P**÷148,000

Page 15-6; Subarticle 1510-3 (B) Line 32 Testing and Sterilization; seventh paragraph delete the words "may be performed concurrently or" and replace with "shall be performed".
