PROJECT SPECIAL PROVISIONS

**Utility Construction** 

All proposed utility construction shall meet the applicable requirements of the NC Department of Transportation's "Standard Specifications for Roads and Structures" dated January 2012.

## Division 15 of the Standard Specifications is revised as follows:

## Page 15-1, Insert New Paragraph After Paragraph 2 of Section 1500-2

The water and sewer lines along this project belong to the City of Hendersonville. Below is listed the utility owner with contact information along this project. Any work on these lines must be coordinated through the Engineer and the utility owner before commencement of any work.

## Page 15-2, Revise Last Sentence of Paragraph 3 of Section 1500-7

Provide the Utility Owner and Engineer with 2 copies of <u>surveyed</u> As-Builts of both the water and sewer systems constructed.

#### Page 15-3, Insert New Paragraph After Paragraph 1 of Section 1500-9

Contractor shall notify the City of Hendersonville 7 business days in advance of performing any tie-in work. Contractor shall notify all affected customers 24 hours in advance of service interruptions. Contractor shall notify all affected critical facilities (i.e. hospitals, schools, medical facilities, etc.) 72 hours or more in advance of service interruption.

# Page 15-2, Revise The Second Sentence in Paragraph 2 of Section 1500-9

The maximum interruption time for the City of Hendersonville water service is four (4) hours. Any additional time needed shall be approved by the City and the Engineer prior to beginning work.

## Page 10-57, Replace Paragraph 1 of Subsection A of Section 1034-4

All ductile iron pipe shall be Class 350 unless otherwise specified and shall be lined with cement mortar not less than 1/16 inch thick conforming to ANSI Specification A21.4.

# Page 10-58, Replace Paragraph 1 of Section 1036-5

All ductile iron pipe shall be Class 350 unless otherwise specified and shall be lined with cement mortar not less than 1/16 inch thick conforming to ANSI Specification A21.4.

## Compensation:

No direct payment will be made for utility construction work required by the preceding provisions, which are general requirements applying to utility construction, and all of the requirements stated will be considered incidental work, paid for at the contract unit prices of the various utility items included in the contract.

  - 8" Steel, -L- Sta. 65+00+/- to Sta. 106+00+/- Sheets UO-6 to UO-9
- 3. The Contractor is to give PSNC a minimum of two (2) weeks to make any adjustments in the areas where the existing lines are to remain in place and adjustments are needed to avoid storm drainage, water, or sewer lines.
- 4. All other areas in which relocations/adjustments are warranted, the Contractor is to give a minimum one (1) week notice.
- 5. All other utility relocation work not listed above is to be completed by the Date of Availability.
