## **Hazardous Materials Report**

The GeoEnvironmental Section of the Geotechnical Engineering Unit has investigated the above referenced project to identify hazardous material sites for inclusion in the environmental document.

#### **HAZARDOUS MATERIALS EVALUATION**

#### **Purpose**

This section presents the results of a hazardous material evaluation conducted along the above referenced project. The main purpose of this investigation is to identify properties within the project study area that are or may be contaminated and therefore result in increased project costs and future liability if acquired by the Department. Hazardous material impacts may include, but are not limited to, active and abandoned underground storage tank (UST) sites, hazardous waste sites, regulated landfills and unregulated dumpsites.

### **Techniques/Methodologies**

The Geographical Information System (GIS) was consulted to identify known sites of concern in relation to the project corridor. Geotechnical Engineering Unit personnel conducted a field reconnaissance along the 7.4 mile project corridor on December 14, 2010. A search of appropriate environmental agencies' databases was performed to assist in evaluating sites identified during this study.

#### **Findings**

#### **UST Facilities**

Based on our study, five sites may contain petroleum USTs within the project limits.

#### **Hazardous Waste Sites**

No Hazardous Waste Sites were identified within the project limits.

#### Landfills

No apparent landfills were identified within the project limits.

#### Other GeoEnvironmental Concerns

No other geoenvironmental concerns were identified within the project limits.

### **Anticipated Impacts**

Five possible UST facilities were identified within the proposed project corridor. We anticipate low monetary and scheduling impacts resulting from these sites. (See the following table and appendices for details)

This facility currently operates as a convenience store & gas station. It is located in the fork between Old Beatty Ford Road and Lentz Road. The tank bed is located approximately 45 feet from the Lentz Road centerline. According to the UST Section registry there are two tanks currently in use. A groundwater incident occurred in April 1992 while under the ownership of the Carolina Oil Company. The site has since received a No Further Action and the incident closed out in May 1992. There are no monitoring wells on site. This site is anticipated to present low geoenvironmental impacts to the project.

This facility currently operates as a convenience store & gas station. It is located in the southwest quadrant of Old Beatty Ford Road and Old Concord Road intersection. The tank bed is located approximately 40 feet from the Old Beatty Ford Road centerline. According to the UST Section registry there are two tanks currently in use. Four tanks were removed in 1993. There are monitoring wells on site and Ground Water Incident # 08516 has been assigned to this facility. **This site is anticipated to present low geoenvironmental impacts to the project.**

The parcel currently operates as a farm tractor repair shop which is located several hundred feet north of the highway. The entrance is 450 feet west of Log Barn Farm Drive. A Sinclair Gas sign is located at the entrance and 80 feet north of the Old Beatty Ford Road centerline. According to the UST Section registry four tanks were removed from this parcel in 1985. A groundwater incident occurred in March 1990 and the incident closed out in April 1990. There are no monitoring wells on site. **This site is anticipated to present low geoenvironmental impacts to the project.**

This storage building once operated as a gas station as confirmed by local residents. It is located in the south side of Old Beatty Ford Road and approximately 600 feet east of Phaniel Church Road. The front of the structure is 50 feet from the Old Beatty Ford centerline. This facility does not appear on the UST Section registry and no monitoring wells were noted. **This site is anticipated to present low geoenvironmental impacts to the project.**


This facility currently operates as a convenience store & gas station. It is located in the south quadrant of Old Beatty Road and Organ Church Road intersection. The tank bed is located approximately 100 feet from the center of the intersection. According to the UST Section registry there are four tanks currently in use. There are no monitoring wells on site and no ground water incidents associated with this facility. This site is anticipated to present low geoenvironmental impacts to the project.

The Geotechnical Engineering Unit can provide assessments on each of the above properties after identification of the selected alternative and before right of way acquisition. Please note that discovery of additional sites not recorded by regulatory agencies and not reasonably discernable during the project reconnaissance may occur. The Geotechnical Engineering Unit should be notified immediately after discovery of such sites so their potential impact(s) may be assessed.
