responses. It's <u>jbrittain@tgsengineers.com</u>. Here is some information that I got from him on the temporary crossings:

- The link below is the information about the temporary private road crossing that the contractor would be applying for. The application would be completed by the contractor and submitted for review and approval. Application approval typically takes 4-6 weeks.
- The required insurance is a separate policy from that required to build the structure.
- The exhibit should include the size of the crossing and the materials used. Stone is recommended to meet ballast requirements so that it can be blended after removal. Drainage should be maintained with piping.
- Gates will be required on each side of the railroad right of way which will be locked by the railroad. Flagging will be required and the gate will be unlocked by the flagger.

Site 4 questions should be answered by the forthcoming SP addendum.
