The completion date for this intermediate contract time is **the date that is sixty (60) consecutive calendar days after the date of availability.**

The liquidated damages are **Two Thousand Dollars (\$ 2,000.00)** per calendar day.

The Contractor shall complete the required work of installing, maintaining, and removing the traffic control devices for lane closures and restoring traffic to the existing traffic pattern. The Contractor shall not close or narrow a lane of traffic on **the following Maps** during the following time restrictions:

DAY AND TIME RESTRICTIONS**MAP #1 (EBL)****Monday thru Thursday, 6:00 AM to 8:00 AM****Friday thru Sunday, No Work Allowed****MAP #2 (WBL)****Monday thru Friday, 6:00 AM to 8:00 AM****Saturday & Sunday, No Work Allowed**

In addition, the Contractor shall not close or narrow a lane of traffic on **Any Map**, detain and/or alter the traffic flow on or during holidays, holiday weekends, special events, or any other time when traffic is unusually heavy, including the following schedules:

HOLIDAY AND HOLIDAY WEEKEND LANE CLOSURE RESTRICTIONS

1. For **any unexpected occurrence** that creates unusually high traffic volumes, as directed by the Engineer.
2. For **New Year's**, between the hours of **6:00 AM** December 30th to **7:00 PM** January 3rd.
3. For **Easter**, between the hours of **6:00 AM** Thursday and **7:00 PM** Monday.
4. For **Memorial Day**, between the hours of **6:00 AM** Friday and **7:00 PM** Tuesday.
