


### SIGNING FOR RESURFACING PROJECTS





# -Y- LINE SIGNING

## MAINLINE (-L-) SIGNING

#### PLACE 1000' PRIOR TO BEGINNING OF CONSTRUCTION LIMITS. ONLY USED ON -Y- LINES IF RESURFACING LIMITS EXTEND 1000' ALONG -Y- LINE. WORK NOTES AND PER DIRECTION AHEAD #2 SIGN ONLY USED WHEN CONSTRUCTION LIMITS ARE 2 OR MORE MILES IN LENGTH. 2 ROUND UP TO NEXT WHOLE NUMBER. (NO FRACTIONAL OR DECIMAL NUMBERS) - PLACE INITIALLY AT THE CONSTRUCTION LIMITS AND SPACE 1 MILE APART LOW/SOFT (3) HOULDER - AT TEE INTERSECTIONS INSTALL INITIALLY 1/2 MILE FROM INTERSECTION SP 13107 48" X 48" AND SPACE 1 MILE APART THEREAFTER. - THESE ARE FOR -Y- LINES THAT ARE "THROUGH" ROADWAYS. SIGNING - DEAD END AND SUBDIVISION ROADS ARE NOT "THROUGH" ROADWAYS. PLACEMENT - INSTALL 500' +/- FROM EACH -Y- LINE APPROACH AS SHOWN ABOVE. UNDER - FOR MULTIPLE -Y- LINES THAT ARE SEPARATED BY 0.25 MILES OR LESS, TREAT AS A SINGLE UNIT AND INSTALL WITHIN 500' OF EACH APPROACH. - A MAXIMUM OF 2 SIGN SETS PER MILE. DO NOT INSTALL WHEN -Y- LINES

ALONG -L- LINE.

## NO REQUIRED STATIONARY SIGNING FOR THE FOLLOWING -Y- LINE CONDITIONS:

- 1) LESS THAN 1000' OF RESURFACING ALONG -Y- LINE
- 2) SUBDIVISION ROADS
- 3) DEAD END ROADS

WHEN PAVING/CONSTRUCTION ACTIVITIES PROCEED ACROSS AN UNSIGNED -Y- LINE, PORTABLE ADVANCE WARNING SIGNS SHALL BE USED ALONG THE -Y- LINE AS SHOWN BELOW. REMOVE UPON COMPLETION OF WORK.



PLACED 500' IN ADVANCE OF FLAGGER.



PLACED 250' IN ADVANCE OF FLAGGER.

ROAD WORK G20–2 A 48" X 24"

PLACE 500' FOLLOWING THE END OF CONSTRUCTION LIMITS OR AS SHOWN WHEN WORK ENDS AT A 3-WAY TEE INTERSECTION.

- FOR TEE INTERSECTIONS, INSTALL WITHIN 500' +/- OF THE INTERSECTION

ARE WITHIN 0.5 MILES FROM "END ROAD WORK" SIGN.

THE ABOVE SIGNS ARE ALL THAT ARE REQUIRED FOR A CONTRACTOR TO BEGIN A RESURFACING CONTRACT. ANY ADDITIONAL SIGNS REQUESTED BY NCDOT DIVISIONS SHALL BE INSTALLED WITHIN 7 BUSINESS DAYS OF THE START OF CONTRACT WORK.

MAPS LESS THAN 2 MILES

FOR RESURFACING MAPS WITH CONSTRUCTION LIMITS LESS THAN 2 MILES IN LENGTH, NO STATIONARY SIGNS ARE REQUIRED. USE PORTABLE "ROAD UNDER CONSTRUCTION" OR "ROAD WORK AHEAD" SIGNS IN LIEU OF STATIONARY ADVANCE WARNINGS SIGNS.
