CHANGES MAY BE REQUIRED WHEN PHYSICAL DIMENSIONS IN THE DETAIL DRAWINGS, STANDARD DETAILS, AND ROADWAY DETAILS ARE NOT ATTAINABLE TO MEET FIELD CONDITIONS OR RESULT IN DUPLICATE OR UNDESIRED OVERLAPPING OF DEVICES. MODIFICATION MAY INCLUDE: MOVING, SUPPLEMENTING, COVERING, OR REMOVAL OF DEVICES AS DIRECTED BY THE ENGINEER.

THE FOLLOWING GENERAL NOTES APPLY AT ALL TIMES FOR THE DURATION OF THE CONSTRUCTION PROJECT EXCEPT WHEN OTHERWISE NOTED IN THE PLAN OR DIRECTED BY THE ENGINEER.

- 1. FOR ANY UNEXPECTED OCCURRENCE THAT CREATES UNUSUALLY HIGH TRAFFIC VOLUMES, AS DIRECTED BY THE ENGINEER.
- 2. FOR NEW YEAR'S, BETWEEN THE HOURS OF 5:00 A.M. DECEMBER 31st TO 10:00 P.M. JANUARY 2ND. IF NEW YEAR'S DAY IS ON A FRIDAY, SATURDAY, SUNDAY, OR MONDAY THEN UNTIL 10:00 P.M. THE FOLLOWING TUESDAY.
- 3. FOR EASTER, BETWEEN THE HOURS OF 5:00 A.M. THURSDAY AND 10:00 P.M. MONDAY.
- 4. FOR MEMORIAL DAY, BETWEEN THE HOURS OF 5:00 A.M. FRIDAY TO 10:00 P.M. TUESDAY.
- 5. FOR INDEPENDENCE DAY, BETWEEN THE HOURS OF 5:00 A.M. THE DAY BEFORE INDEPENDENCE DAY AND 10:00 P.M. THE DAY AFTER INDEPENDENCE DAY.

 IF INDEPENDENCE DAY IS ON A FRIDAY, SATURDAY, SUNDAY OR MONDAY THEN BETWEEN THE HOURS OF 5:00 A.M. THE THURSDAY BEFORE INDEPENDENCE DAY AND 10:00 P.M. THE TUESDAY AFTER INDEPENDENCE DAY.
- 6. FOR LABOR DAY, BETWEEN THE HOURS OF 5:00 A.M. FRIDAY AND 10:00 P.M. TUESDAY.
- 7. FOR THANKSGIVING DAY, BETWEEN THE HOURS OF 5:00 A.M. TUESDAY TO 10:00 P.M. MONDAY.
- 8. FOR CHRISTMAS, BETWEEN THE HOURS OF 5:00 A.M. THE FRIDAY BEFORE THE WEEK OF CHRISTMAS DAY AND 10:00 P.M. THE FOLLOWING TUESDAY AFTER THE WEEK OF CHRISTMAS.
- C) DO NOT CONDUCT ANY HAULING OPERATIONS AGAINST THE FLOW OF TRAFFIC OF AN OPEN TRAVELWAY UNLESS THE HAULING OPERATION IS PROTECTED BY BARRIER OR GUARDRAIL OR AS DIRECTED BY THE ENGINEER.

LANE AND SHOULDER CLOSURE REQUIREMENTS

- D) REMOVE LANE CLOSURE DEVICES FROM THE LANE WHEN WORK IS NOT BEING PERFORMED BEHIND THE LANE CLOSURE OR WHEN A LANE CLOSURE IS NO LONGER NEEDED OR AS DIRECTED BY THE ENGINEER.
- E) WHEN PERSONNEL AND/OR EQUIPMENT ARE WORKING WITHIN 15 FT OF AN OPEN TRAVEL LANE, CLOSE THE NEAREST OPEN SHOULDER USING ROADWAY STANDARD DRAWING NO. 1101.04 UNLESS THE WORK AREA IS PROTECTED BY BARRIER OR GUARDRAIL OR A LANE CLOSURE IS INSTALLED.
- F) WHEN PERSONNEL AND/OR EQUIPMENT ARE WORKING WITHIN 5 FT OF AN OPEN TRAVEL LANE ON AN UNDIVIDED FACILITY, CLOSE THE NEAREST OPEN TRAVEL LANE USING ROADWAY STANDARD DRAWING NO. 1101.02 UNLESS THE WORK AREA IS PROTECTED BY BARRIER OR GUARDRAIL.
 - WHEN PERSONNEL AND/OR EQUIPMENT ARE WORKING WITHIN 10 FT OF AN OPEN TRAVEL LANE ON A DIVIDED FACILITY, CLOSE THE NEAREST OPEN TRAVEL LANE USING ROADWAY STANDARD DRAWING NO. 1101.02 UNLESS THE WORK AREA IS PROTECTED BY BARRIER OR GUARDRAIL.
- G) WHEN PERSONNEL AND/OR EQUIPMENT ARE WORKING WITHIN A LANE OF TRAVEL OF AN UNDIVIDED OR DIVIDED FACILITY, CLOSE THE LANE ACCORDING TO THE TRAFFIC CONTROL PLANS, ROADWAY STANDARD DRAWINGS, OR AS DIRECTED BY THE ENGINEER. CONDUCT THE WORK SO THAT ALL PERSONNEL AND/OR EQUIPMENT REMAIN WITHIN THE CLOSED TRAVEL LANE.
- H) DO NOT WORK SIMULTANEOUSLY WITHIN 15 FT ON BOTH SIDES OF AN OPEN TRAVELWAY, RAMP, OR LOOP WITHIN THE SAME LOCATION UNLESS PROTECTED WITH GUARDRAIL OR BARRIER.

PAVEMENT EDGE DROP OFF REQUIREMENTS

I) DO NOT EXCEED A DIFFERENCE OF 2 INCHES IN ELEVATION BETWEEN OPEN LANES OF TRAFFIC FOR NOMINAL LIFTS OF 1.5 INCHES. INSTALL ADVANCE WARNING "UNEVEN LANES" SIGNS (W8-11) IN ADVANCE AND A MINIMUM OF EVERY HALF MILE THROUGHOUT THE UNEVEN AREA.

TRAFFIC PATTERN ALTERATIONS

J) NOTIFY THE ENGINEER THIRTY (30) CALENDAR DAYS PRIOR TO ANY TRAFFIC PATTERN ALTERATION.

SIGNING

- () INSTALL ADVANCE WORK ZONE WARNING SIGNS WHEN WORK IS WITHIN 40 FT FROM THE EDGE OF TRAVEL LANE AND NO MORE THAN THREE (3) DAYS PRIOR TO THE BEGINNING OF CONSTRUCTION.
- PROVIDE SIGNING AND DEVICES REQUIRED TO CLOSE THE ROAD ACCORDING TO THE ROADWAY STANDARD DRAWINGS AND TRAFFIC CONTROL PLANS.

 PROVIDE SIGNING REQUIRED FOR THE OFF-SITE DETOUR ROUTE AS SHOWN IN THE TRAFFIC CONTROL PLANS.
- COVER OR REMOVE ALL SIGNS AND DEVICES REQUIRED TO CLOSE THE ROAD WHEN ROAD CLOSURE IS NOT IN OPERATION.

 COVER OR REMOVE ALL SIGNS REQUIRED FOR THE OFF-SITE DETOUR WHEN THE DETOUR IS NOT IN OPERATION.
- N) ENSURE ALL NECESSARY SIGNING IS IN PLACE PRIOR TO ALTERING ANY TRAFFIC PATTERN.
- INSTALL BLACK ON ORANGE "DIP" SIGNS (W8-2) AND/OR "BUMP" SIGNS (W8-1) 250 FT IN ADVANCE OF THE UNEVEN AREA, OR AS DIRECTED BY THE ENGINEER.

TRAFFIC CONTROL DEVICES

- P) WHEN LANE CLOSURES ARE NOT IN EFFECT SPACE CHANNELIZING DEVICES IN WORK AREAS NO GREATER IN FEET THAN TWICE THE POSTED SPEED LIMIT (MPH) EXCEPT, 10 FT ON-CENTER IN RADII, AND 3 FT OFF THE EDGE OF AN OPEN TRAVELWAY. REFER TO STANDARD SPECIFICATIONS FOR ROADS AND STRUCTURES SECTIONS 1130 (DRUMS), 1135 (CONES) AND 1180 (SKINNY DRUMS) FOR ADDITIONAL REQUIREMENTS.
- Q) PLACE TYPE III BARRICADES, WITH "ROAD CLOSED" SIGN R11-2 ATTACHED, OF SUFFICIENT LENGTH TO CLOSE ENTIRE ROADWAY.
- R) PLACE ADDITIONAL SETS OF THREE CHANNELIZING DEVICES DRUMS PERPENDICULAR TO THE EDGE OF TRAVELWAY ON 500 FT CENTERS WHEN UNOPENED LANES ARE CLOSED TO TRAFFIC.

PHASING NOTES

STEP

USING RSD 1101.01, INSTALL WORK ZONE ADVANCE WARNING SIGNS ON CLIFFDALE ROAD AND ALL AMERICAN FREEWAY.

STEP 2

INSTALL AND COVER DETOUR AND ADVANCE WARNING SIGNS FOR NIGHTLY CLOSURE OF EASTBOUND DIRECTION OF BRIDGE ON CLIFFDALE ROAD (SEE DETOUR ON TMP-7). PORTABLE MOUNTED SIGNS CAN BE USED FOR THE DETOUR SIGNS IN LIEU OF STATIONARY MOUNTED SIGNS.

STEP 3

USING RSD 1101.02 (SHEET 3 OF 19), UTILIZE NIGHTLY LANE CLOSURES OF CLIFFDALE ROAD EASTBOUND, UNCOVER DETOUR SIGNAGE, PLACE BARRICADES, AND SHIFT TRAFFIC INTO TEMPORARY EXIT ONLY PATTERN. CLOSE SIDEWALK APPROACHES AT THE END OF THE BRIDGE USING PEDESTRIAN CHANNELIZING DEVICES. COMPLETE WORK ON EASTBOUND SIDE OF BRIDGE DECK (SEE TMP-3 AND TMP-4). PLACE TYPE 4 TAPE TEMPORARY MARKINGS WHEN NEEDED TO MAINTAIN EXISTING TRAFFIC PATTERN. REOPEN CLIFFDALE ROAD TO TRAFFIC AT THE END OF THE WORK PERIOD. REPEAT AS NECESSARY TO COMPLETE THE EASTBOUND SIDE OF THE BRIDGE DECK.

STEP 4

INSTALL AND COVER DETOUR AND ADVANCE WARNING SIGNS FOR NIGHTLY CLOSURE OF WESTBOUND DIRECTION OF BRIDGE ON CLIFFDALE ROAD (SEE DETOUR ON TMP-8). PORTABLE MOUNTED SIGNS CAN BE USED FOR THE DETOUR SIGNS IN LIEU OF STATIONARY MOUNTED SIGNS.

STEP 5

USING RSD 1101.02 (SHEET 3 OF 19), UTILIZE NIGHTLY LANE CLOSURES OF CLIFFDALE ROAD WESTBOUND, UNCOVER DETOUR SIGNAGE, PLACE BARRICADES, AND SHIFT TRAFFIC INTO TEMPORARY EXIT ONLY PATTERN. CLOSE SIDEWALK APPROACHES AT THE END OF THE BRIDGE USING PEDESTRIAN CHANNELIZING DEVICES. COMPLETE WORK ON WESTBOUND SIDE OF BRIDGE DECK (SEE TMP-5 AND TMP-). PLACE TYPE 4 TAPE TEMPORARY MARKINGS WHEN NEEDED TO MAINTAIN EXISTING TRAFFIC PATTERN. REOPEN CLIFFDALE ROAD TO TRAFFIC AT THE END OF THE WORK PERIOD. REPEAT AS NECESSARY TO COMPLETE THE WESTBOUND SIDE OF THE BRIDGE DECK.

STEP 6

USING RSD 1101.02 (SHEET 3 OF 19), UTILIZE NIGHTLY LANE CLOSURES AND TEMPORARILY CLOSE THE OUTSIDE LANES OF ALL AMERICAN FREEWAY TO COMPLETE WORK UNDERNEATH THE BRIDGE DECK




USING RSD 1101.02 (SHEET 3 OF 19), UTILIZE NIGHTLY LANE CLOSURES AND TEMPORARILY CLOSE THE INSIDE LANES OF ALL AMERICAN FREEWAY TO COMPLETE WORK UNDERNEATH THE BRIDGE DECK.

STEP 8

REMOVE ALL ADVANCE WARNING DEVICES AND OPEN TRAFFIC TO FINAL PATTERN.


