Best Geological and Environmental Consulting, P.A. (Best) is pleased to provide this Initial Abatement Report for the spill site located on I-77 south Mile Marker 83 in Elkin, North Carolina (see Figure 1). The purpose of the assessment was to confirm that soil containing diesel fuel exceeding the state action limit had been removed from the site.

### 1 Introduction

The spill occurred on August 22, 2020, when a south bound tractor trailer ran off the right side of the road struck a guardrail and came to a stop against the bridge rail. The truck lost an undetermined amount of diesel fuel. Most of the diesel fuel spilled onto the roadway and flowed through a vertical drain pipe onto a bed of rip rap beneath the bridge. A copy of the accident report is included in Appendix A. Absorbent materials were used at the time of the accident to recover as much of the diesel fuel as possible and contain the spill.

## 2 Soil Excavation

On August 24, 2020, Best was on the site to monitor the excavation of the diesel fuel contaminated soil and rip rap performed by Ultimate Towing and Recovery and collect confirmation soil samples after the completion of the excavation. Ultimate Towing and Recovery removed the impacted soil using an excavator and skid steer then loaded the

soil onto dump trucks. During the excavation, Best continuously examined soil samples for evidence of contamination. The excavation was terminated when it appeared that all contaminated soil had been removed. The final excavation was rectangular in shape with dimensions measured at 140 feet long by 30 feet wide by one to three feet deep. No groundwater or competent rock was encountered during the excavation. Soils encountered included rip rap and alluvial material composed of brown to tan silty sand.

Ultimate Towing and Recovery transported 209.67 tons of contaminated soil to AES of NC in Thomasville, North Carolina for treatment. A copy of the disposal manifests are included in Appendix B. One composite soil sample (SP) was collected from the removed soil and transported under chain of custody control to Research & Analytical Laboratories in Kernersville, North Carolina (R&A) to be analyzed for diesel range total petroleum hydrocarbons (TPH) and gasoline range TPH. The composite soil sample contained 508 milligrams per kilogram (mg/kg) of diesel range TPH and 18.0 mg/kg of gasoline TPH. The laboratory report is contained in Appendix C. Photographs of the field activities are included in Appendix D.

# 3 Confirmation Soil Sampling

At the conclusion of the excavation Best collected four confirmation soil sample (S1, S2, S3 and S4) from the bottom of the excavation using a decontaminated hand auger (see Figure 2). The soil samples were transported under chain of custody control to R&A to be analyzed for diesel and gasoline range TPH. The laboratory analyses did not indicate the presence of diesel or gasoline range TPH in any of the soil samples (see Appendix C).

## 4 Conclusions and Recommendations

Based on the results of the laboratory analyses and our field observations, it appears that all of the diesel contaminated soil has been removed from the spill area. We recommend no further action.
