VCOM Driver 2.3.0.2

- Get plug and unplug notification when a VCOM device connects and disconnects in CortexTools2.
- Microsoft signed driver file has been integrated.
- Catalog files are signed using VeriSign certificates.
- The driver version will now be displayed in the properties of the driver in device manager.
- VCOMPSW-19 – Upgrade/downgrade messages are not meaningful.
- VCOMPSW-21 – VCOM driver installation fails when installing it on a computer with a new installation of Windows 7.
- VCOMPSW-22 – VCOM uninstaller attempts uninstallation when the driver is not on the computer.
- VCOMPSW-23 – VCOM driver is uninstalled without any confirmation.

- Add support for multiple cabled VCOM devices and a single modem VCOM device.
- Added the capability for a silent install.
