## REQUEST FOR THE NAMING OF BRIDGE ON US 70 OVER SALTER CREEK, CARTERET COUNTY

Our Department of Transportation has under construction a new bridge and approaches on US 70 over Salter Creek (Nelson Bay) located near the community of Sea Level in Carteret County. The contract completion date for this project is December 1, 1982.

G. S. 136-18(8) places with our Department of Transportation the power "To give suitable names to State highways and change the names as determined by the Board of Transportation of any highways that shall become a part of the State system of highways".

It has been the policy of our Board of Transportation to give consideration to names for highway facilities where such requests are officially endorsed by the respective local governing bodies.

On January 4, 1982, the Carteret County Board of Commissioners in response to a petition from residents of the Sea Level Community adopted a resolution requesting the Department of Transportation to name the new bridge on US 70 over Salter Creek the "DAN TAYLOR MEMORIAL BRIDGE". A copy of Chairperson Mary Sue Noe's letter of January 6, 1982, and a copy of the resolution are attached.

It is recommended the Board of Transportation approve the name "DAN TAYLOR MEMORIAL BRIDGE" for this new bridge and authorize the Department to erect an appropriate sign at each end of the bridge.
