**WHEREAS**, Roy Eugene "Gene" Ashe was born on March 29, 1957 and was a life-long resident of Jackson County; and

**WHEREAS**, Roy Eugene "Gene" Ashe attended Sylva-Webster High School and graduated from Southwestern Community College in Sylva; and

**WHEREAS**, Roy Eugene "Gene" Ashe graduated from the North Carolina Department of Motor Vehicles School; and

**WHEREAS**, Roy Eugene "Gene" Ashe was employed by the Jackson County Emergency Medical Services and the Jackson County Sheriff's Department; and

**WHEREAS**, Deputy Sheriff Roy Eugene "Gene" Ashe was a member of the Jackson County Sheriff's Department for 14 years; and

**WHEREAS**, on April 13, 1995, Deputy Sheriff Roy Eugene "Gene" Ashe suffered a fatal heart attack following a high-speed pursuit that went through narrow, steep mountain roads in three different counties; and

**WHEREAS**, Deputy Sheriff Roy Eugene "Gene" Ashe was a member of the Fraternal Order of Police, Woodmen of the World and attended Sylva First Baptist Church; and

**WHEREAS**, The Jackson County Board of Commissioners requested the North Carolina Board of Transportation honor Deputy Roy Eugene "Gene" Ashe.

**NOW, THEREFORE, BE IT RESOLVED:**

That the North Carolina Board of Transportation dedicates U.S. 441 from the bottom to the top of Cowee Mountain in Jackson County as the **Deputy Gene Ashe Highway** for his dedicated service and self sacrifice to the citizens of Jackson County and the state of North Carolina.

That appropriate signs be erected at a suitable time.
