SECTION 29.10. The Department of Transportation may use funds not to exceed seventy-five hundredths of one percent (.75%) of the funds appropriated in this act to the Department for maintenance and construction programs for major repair renovation, or replacement of facilities that fail to meet safety standards or that are obsolete for current or future use. Prior to expending these funds, the Department shall submit its proposed budget for these expenditures to the Senate Appropriations Subcommittee on Department of Transportation, the House of Representatives Appropriations Subcommittee on Transportation, and the Joint Legislative Transportation Oversight Committee each year.

\* Amendment: "A study of the market value of the Departments real estate/facilities be conducted and an evaluation be done of the potential benefits of the sale of obsolete/unsafe facilities be completed. The intended result of this study may result in possible revisions to the existing procedures."

**WHEREAS**, the Clay County Board of Commissioners requests that the N.C. Department of Transportation honor the late Clay County doctor for the esteem, respect and honor he has brought to Clay County.

## Now, Therefore, Be It Resolved:

That the North Carolina Board of Transportation names the U.S. 64 Bypass in Clay County the *Dr. Joe C. Padgett Memorial Highway* for his outstanding service to his community, state and nation.

That appropriate signs be erected at a suitable time.
