concurrence in Resolution of Richmond County Board of Commissioners and Town of Rockingham to name Highway US 220 from Ellerbe to US 1 in Rockingham the "J. Elsie Webb Thoroughfare"

The Commission, in accordance with Commissioner Allen's motion, went on record as concurring in a resolution adopted by the Richmond County Board of Commissioners and the Town of Rockingham on December 8, 1971, designating the section of US 220 from Ellerbe to US 1 in Rockingham as the "J. Elsie Webb Thoroughfare", which motion was seconded by Commissioner Joyce, and unanimously carried.

The resolution adopted by the Richmond County Board of Commissioners and the Town of Rockingham and concurred in by the Highway Commission is as follows:

"WHEREAS, J. Elsie Webb of Richmond County, N. C. has for many years made valuable contributions to this county all of which have contributed to the health and welfare of the people of this county as well as the economic growth and stability of the business community of the county;

"AND WHEREAS, J. Elsie Webb has been instrumental in obtaining for Richmond County many government projects which were greatly needed in this area;

"AND WHEREAS, J. Elsie Webb has for many years most generously given his time and energy to public projects and these projects have been of great benefit to the people;

"AND WHEREAS, one of these projects was the improvement of U. S. Highway 220 between Ellerbe and through Rockingham;

"AND WHEREAS, the improvement of U. S. Highway 220 in Richmond County was initiated while Mr. Webb served as a member of the North Carolina State Highway Commission and this project is the only major highway improvement project in Richmond County within the last twenty years;

"NOW, THEREFORE, BE AND IT IS HEREBY RESOLVED that the section of U. S. Highway 220 from Ellerbe, N. C. to its intersection with U. S. Highway 1 South of Rockingham, N. C. be designated as 'J. Elsie Webb Thoroughfare'."
