Concurrence - Resolution Re Naming Section of Road in Washington County "Ken Trowbridge Road"

Public Information Officer Laney advised the Washington County Board of Commissioners adopted the following resolution on March 1, 1971, requesting the State Highway Commission to name access road connecting US 64 to the Weyerhaeuser Company Complex in Plymouth in honor of the late Ken Trowbridge, in recognition of Mr. Trowbridge's outstanding record of public service to the citizens of Washington-Martin County area, and requested the Commission's concurrence in this resolution.

Accordingly, a motion was made by Commissioner Gillam that this access road between US 64 and the Weyerhaeuser Company Complex be named 'Ken Trowbridge Road'. The motion was seconded by Commissioner Ellis, and unanimously carried.

"WHEREAS, the late Ken Trowbridge was a citizen and resident of Plymouth in Washington County and was employed for many years as an official at Weyerhaeuser Company at its plant in Martin County and near the Town of Plymouth, and

"WHEREAS, Ken Trowbridge was well known through the Washington-Martin County area, and did much to promote Weyerhaeuser's image in the Washington-Martin County area, and that for and on account of his work it is fitting that he should be remembered by the people of the area;

"NOW, THEREFORE, be it resolved by the Board of Commissioners for the County of Washington that the access road connecting U. S. Highway No. 64 and the Plymouth complex of Weyerhaeuser Company be and the same should be named the Ken Trowbridge Road, and the North Carolina State Highway Commission is hereby petitioned to officially and formally so name the said road in honor of this distinguished citizen.
