Approval - Naming of NC 12, Dare-Hyde Counties, the
"MARC BASNIGHT HIGHWAY"

Administrator Rose advised the Department has received requests from the Dare County Board of Commissioners and the Hyde County Board of Commissioners to name the portion of NC 12 from its terminus with US 64-264 at Whalebone Junction in Dare County to its terminus at the ferry dock in Ocracoke Village in Hyde County as the "Marc Basnight Highway". He said similar resolutions have also been adopted by the Albemarle Commission, Southern Albemarle Association's Executive Committee and by the Manteo Town Board of Commissioners. Administrator Rose noted it has been the policy of our Board to give consideration to names for highway facilities where such requests are officially endorsed by the respective local governing bodies. He recommended approval of the requests.

A motion was made by Board Member Campbell, seconded by Board Member Joyner, and the vote was unanimous to approve the name "MARC BASNIGHT HIGHWAY" for NC 12 from US 64-264 at Whalebone Junction in Dare County to the ferry dock in Ocracoke Village in Hyde County and authorize the Department to erect appropriate signs.

Approval - Naming of US 521, Mecklenburg County, the "JAMES K. POLK
MEMORIAL HIGHWAY"

Administrator Rose advised the Department has received requests from the Mecklenburg County Board of Commissioners and the Town of Pineville to name the portion of US 521 from Tyvola Road to the North Carolina - South Carolina State Line as the "James K. Polk Memorial Highway". He recommended approval by the Board.

Accordingly, on a motion by Board Member Burnette, seconded by Board Member Ponder, the vote was unanimous to approve the name
