SUBJECT:

Designation of US 13 as the Robert Burton Nelson Highway

At its meeting on November 7, 1975, the Board of Transportation named the portion of US 13 extending from the N. C. - Virginia State line to I-95 in Cumberland County the Robert Burton Nelson Highway. In accordance with instructions from Mr. Billy Rose, we are sending to your Traffic Services Supervisor the design of the sign to be erected along US 13 showing this designation. This sign is 30" x 15", white on green background, 3" Series C copy, .063" aluminum, reflectorized, with the message "R. B. NELSON HIGHWAY".

Attached is a portion of a North Carolina State map on which we have indicated the approximate locations for 26 signs to be erected along this route. Generally, the signs will be posted on existing confirming route marker assemblies, outside of City or Town limits and scattered at intervals of 5 to 10 miles. The only exception to this will be Division 1 in the Town of Robersonville where separate instructions are to be issued.

The North Carolina Department of Corrections has been furnished a copy of this sign layout and will be in a position to provide you with completed signs as soon as you can provide the necessary requisition. If you have any questions concerning this matter, please advise.
