REQUEST FOR NAMING OF NEW PORTION OF US 221 IN ASHE COUNTY

Our Department of Transportation has under construction a 7.4 mile relocation of US 221 from Baldwin to Jefferson in Ashe County. The new road is nearing completion and requests have been received to name it the "Robert G. Barr Expressway".

General Statute 136-18(8) places with our Department of Transportation the power "To give suitable names to State highways and change the names as determined by the Board of Transportation of any highways that shall become a part of the State System of highways".

It has been the policy of our Board of Transportation to give consideration of names for highway facilities where such requests are officially endorsed by the respective local governing bodies.

The Ashe County Board of Commissioners and the Town of West Jefferson have adopted similar resolutions requesting this new portion of US 221 be named the "Robert G. Barr Expressway". The Ashe County Chamber of Commerce has also adopted a similar resolution. A copy of each resolution is attached.

It is recommended the Board of Transportation approve the name "Robert G. Barr Expressway" for this section of US 221 and authorize the Department to erect appropriate signs.
