**WHEREAS,** Like his father Bruce Barclay Cameron, he was elected mayor of the city of Wilmington, serving from 1955 to 1957 with integrity and tireless devotion; and

**WHEREAS,** Daniel David Cameron and his family have been generous and ardent benefactors of the University of North Carolina at Wilmington, New Hanover Regional Medical Center, the arts and culture of the region and various community organizations; and

**WHEREAS**, The Wilmington City Council and the New Hanover Board of Commissioners requested the North Carolina Department of Transportation honor Daniel David Cameron.

## Approval – Policy on Federally Funded Projects Selected by Entities Other Than the State Board of Transportation
