Adoption - Resolution Naming Overpass Bridge on US 74 Bypass of Whiteville the WORTHINGTON BRIDGE

In compliance with request from the Columbus County
Board of Commissioners and upon the recommendation of the Policy
Committee, Board Member Callahan made a motion that the Board
adopt the following resolution. The motion was seconded by

"WHEREAS, the Board of Transportation has received a resolution from the Columbus County Board of Commissioners requesting the naming of an overpass bridge on the US 74 Bypass of Whiteville in memory of Milton Grey Worthington, a life long resident of Columbus County; and

"WHEREAS, Milton Grey Worthington prior to his death on January 3, 1975, was a long time faithful, dutiful, competent and trustworthy employee of the North Carolina Department of Transportation, Division of Highways; and

"WHEREAS, at the time of his death, Milton Grey
Worthington was serving as an inspector for the construction of
the US 74 Bypass of Whiteville and as a part of said project,
overpasses were being constructed within the city limits of
Whiteville; and

"WHEREAS, in respect to the memory of Milton Grey Worthington, the North Carolina Board of Transportation finds that it would be worthwhile and fitting to memorialize the name of Milton Grey Worthington in recognition of devoted service to the State of North Carolina:

"IT IS NOW, THEREFORE, RESOLVED, by the North Carolina Board of Transportation that the US 701 Business bridge over the US 74 Bypass of Whiteville be named the WORTHINGTON BRIDGE."
