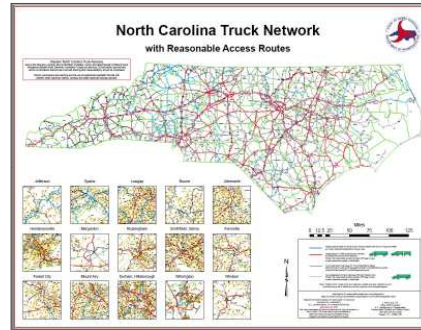


## North Carolina Truck Network

### Summary

Display restricted and non-restricted truck network routes, and display reasonable access routes.

### Description

- All primary highways (US and NC routes) in North Carolina, unless they are non-restricted or restricted, are available for all legal truck and vehicle combinations, except twin trailers (semi-trailer and trailer), in accordance with general statute §20-115.1(b).
- Non-restricted routes are available to all legal truck and vehicle combinations including trucks with twin trailers (semi-trailer and trailer) and trucks with 53-foot semi-trailers. Non-restricted routes include National Network routes (23 CFR 658) and any route designated by the North Carolina Department of Transportation (NCDOT) under general statute §20-115.1 (g).
- Restricted routes are any route where a truck restriction or prohibition exists (not including posted bridge weights or low-weight secondary roads). Restrictions may be based on length, width, weight, number of axles, type of truck, and/or vehicle combination and are usually in place for safety or infrastructure preservation reasons. The truck restriction table should be consulted for specific restrictions on specific roads.
- Reasonable access (RA) routes are terminal and operator specific, must have NCDOT approval, and must connect to either a primary route (for trucks with 53-foot semitrailers) or a non-restricted route (for trucks with 53-foot semitrailers or trucks with twin trailers).
