A. <u>Project Description:</u>

This project proposes to upgrade the traffic signal system in The City of Gastonia, Gaston County. The project includes new fiber optic cables, an upgrade of signal cabinets and controllers, and the installation of new closed-circuit television (CCTV) cameras.

The City of Gastonia currently has 24 CCTV camera assemblies. This project involves replacing the existing CCTV assemblies that currently use analog technologies, with new digital CCTV assemblies. Additionally, 14 new CCTV locations and assemblies will be added to the system. This project also includes upgrades to 141 signals, 132 which are NCDOT-owned. All signals are maintained by the City of Gastonia. An upgrade will be made in the communication system from serial to Ethernet between ITS devices. Emergency vehicle preemption (EVP) infrastructure will also be installed at multiple intersections in partnership with the Gastonia Fire Department with the primary goal of reducing emergency response time.

All proposed improvements would be within the existing right-of-way. No easements are anticipated. Proposed fiber would utilize existing underground conduit or be placed overhead on existing utility poles. Ground disturbance would generally be limited to replacing/relocating signal cabinets and new CCTV pole construction. Signal cabinets would be converted from pole to base mounts at the following intersections:

- Franklin Blvd at Weldon St; cabinet would be relocated from the southwest quadrant to northeast quadrant
- Franklin Blvd at Whitesides St
- Franklin Blvd at York St

- Franklin Blvd at Oakland St
- Airline Ave at Highland St
- Chester St at 3rd Ave
- York St at 2nd Ave
- Chester St at 2nd Ave
 - New Hope Rd at Cramer Mountain Rd

Three new CCTV poles are proposed at the following locations:

- Hudson Blvd at Davis Park Rd, northeast corner
- Garrison Blvd at Union Rd, northeast corner
- Garrison Blvd at Burtonwood Dr, northeast corner




Figure 1. Vicinity of Gastonia showing the proposed upgrade of 145 traffic signals, locations shown as yellow dots, and aerial fiber optics (yellow lines) that, together represent a buffered APE. Planned within existing ROW, impacts will be minimal.

The project is currently scheduled to begin construction in fall of 2022 with a total cost estimate of \$11.4 million. Project intersections and fiber optic cable route locations are shown in **Figure 1**.

B. <u>Description of Need and Purpose:</u>

The need for the project is driven by traffic congestion and Gastonia's aging and inconsistent traffic signal timing system. The purpose of the project is to reduce traffic congestion, improve air quality, and improve the efficiency of Gastonia's transportation network by providing more cohesiveness between signals within Gastonia and surrounding areas as well as reduce emergency response time.

E. Special Project Information:

<u>Tribal Coordination</u>: Tribal coordination letters were sent to the Catawba Indian Nation, United Keetoowah Band of Cherokee Indians, Eastern Band of Cherokee Indians and the Cherokee Nation. The Catawba Indian Nation responded in a letter dated November 3, 2021 stating they have no immediate concerns regarding the project, and should be notified if Native American artifacts and/or human remains are located during the ground disturbance phase of the project. No other responses were received.

<u>Historic Resources</u>: NCDOT reviewed HPO quad maps, relevant background reports, historic designations roster, and indexes on September 16, 2021. Based on this review, a locally-listed historic district required a Certificate of Appropriate from the City of Gastonia Planning Office. On October 8, 2021 the application was approved. No Historic Properties will be affected by this project.





Project Description: NCDOT proposes to upgrade 145 traffic signals, install aerial fiber optic lines on existing utility poles, upgrade signal cabinets and install closed circuit cameras throughout the town of Gastonia in Gaston County. No new ROW is anticipated and ground disturbances will be very minimal. For purposes of this review, the Area of Potential Effects (APE) involves all signal improvement areas and also include narrow, linear aerial fiber optic lines which will use existing utility poles. The APE does indicate the areas considered, even if impacts will be very minor or none at certain portions, and is shown in the figures below.

The project is anticipated to be FHwA funded, therefore this federal undertaking is reviewed under Section 106 of the Nation Historic Preservation Act at it relates to archaeology. The need for a USACE permit is unknown at this time but unlikely based on the nature of the project.

SUMMARY OF CULTURAL RESOURCES REVIEW

Brief description of review activities, results of review, and conclusions:

NCDOT proposes to upgrade several dozens of traffic signals and control boxes, install cameras and also connect systems using aerial fiber optics throughout the greater Gastonia area. While the physical footprint of the project on the ground is very minimal, the larger project does span ten miles across. The APE mapping provided here was generated from the 145 intersection locations for the planned signal upgrades and the many miles of fiber optic lines to be installed above ground on existing utility poles. With very small footprints and no new ROW, the APE has been buffered so that it is visible for the mapping scale.

A previous archaeological review for several ADA ramps in Gaston County was completed in 2019 that has some general overlap and strong relevance to the current project (PA 19-05-0019). For that project, no archaeological survey was recommended based on the small scale and nature of the ground disturbing activities within generally disturbed archaeological context. The current project has less or no new impacts.

To supplement already detailed and relevant mapping provided by the Division, data from the Historic Preservation Office and the Office of State Archaeology was examined. There are several study listed, determined eligible or National Register of Historic Places properties located in the general project area, some adjacent to or overlapping with the project. Notable for their size are the Downtown Gastonia Historic District, the Loray Mill Historic District (and expansion), and the York-Chester Historic District, all listed on the National Register of Historic Places. Others DOE or Study Listed properties include a variety of types, such as brick school houses, neighborhoods and portions of the railway. Cemeteries are nearby or adjacent to the APE. Archaeologically, no impacts to those resources are expected based on the very small or negligible expected ground disturbances within existing ROW.

There are several archaeological sites that have been recorded in the county near Gastonia. A relatively small number are in close proximity to the APE. Not listed on the National Register of Historic Places, two sites 31Gs232, 31Gs274 (a mill / dam) overlap with the APE, including one at a traffic signal and the other

underneath the aerial fiber optic lines. Based on the nature and scale of the project, none of the archaeological sites will be affected by the project.

Much of the project APE is developed and includes urban shoulders of roads and intersections within town. These contexts have been generally disturbed several times by grading, sidewalks, utilities and roadway projects. Expectations are very low that intact portions of significant archaeological sites would be affected by the project.




Figure 2. Aerial showing span of signal replacements and fiber optic routes in Gastonia, Gaston County with the APE shown in yellow. The roadside APE makes a poor archaeological context within existing ROW and which will only have minimal impacts. 2020 PROGRAMMATIC AGREEMENT ARCHAEOLOGY TEAM NO ARCHAEOLOGICAL SURVEY REQUIRED FORM 4 of 4

USGS mapping (Bessemer City, Gastonia North, Gastonia South, Mount Holly Cramerton) and aerial photography was examined but, because of the large coverage, not studied in detail (see Figures 1 and 2).

According to GIS data compiled by NCDOT archaeologist, Paul Mohler, and as noted above, there are mapped cemeteries nearby or in close proximity to the APE though none are expected to be affected.

This project falls within a North Carolina County in which the following federally recognized tribes have expressed an interest: the Cherokee Nation, the Eastern Band of Cherokee Indians, the United Keetoowah Band of Cherokee Indians, and the Catawba Indian Nation. We recommend that you ensure that this documentation is forwarded to these tribes using the process described in the current NCDOT Tribal Protocol and PA Procedures Manual.

Brief Explanation of why the available information provides a reliable basis for reasonably predicting that there are no unidentified historic properties in the APE:

Upgrades for signalization at 145 locations in and around Gastonia, including installation of miles of aerial fiber optic lines, will result in only minimal impacts and no new ROW. The APE is within existing ROW and is generally considered to have disturbed soils due to road construction activities, utilities, and development. There are known historic properties, cemeteries, and archaeological sites nearby, adjacent and overlapping the APE, however, no impacts to archaeological sites are anticipated based on the scale and nature of the undertaking.

The modified, often disturbed ROW does not suggest a high probability for intact archaeological sites within the limited APE. It is unlikely that significant archaeological remains would be present and impacted by the installation of replacement traffic signals, cameras, control boxes and fiber optic lines using existing utility poles. No archaeological survey is recommended. For archaeological review, this undertaking should be considered compliant with Section 106.
