## **Public Hearings**

The North Carolina Department of Transportation (NCDOT) will be holding one Open House and two combined Open House / Public Hearings to provide updates on the Monroe Connector/Bypass project and receive comments on the Draft Supplemental Final Environmental Impact Statement that has recently been completed. The Monroe Connector/Bypass proposes to improve mobility and capacity within the project study area by providing a facility that allows for high-speed regional travel consistent with the NC Strategic Highway Corridor program and the NC Intrastate System, while maintaining access to properties along existing US 74. The project extends from I-485 in Mecklenburg County to US 74 between the towns of Wingate and Marshville, a distance of approximately 20 miles. Project documentation and mapping will be displayed at the Public Hearing, and they are also available online at <a href="http://www.ncdot.gov/projects/monroeconnector/">http://www.ncdot.gov/projects/monroeconnector/</a>.
