The N.C. Department of Transportation will hold public hearings in December regarding the proposed Monroe Connector/Bypass project in Mecklenburg and Union Counties. The project proposes to construct a new location roadway from I-485 to U.S. 74 near the Town of Marshville.

The purpose of the project is to improve mobility and capacity within the project study area by providing a facility for the U.S. 74 corridor from near I-485 in Mecklenburg County to between the towns of Wingate and Marshville in Union County that allows for high-speed regional travel consistent with the designations of the North Carolina Strategic Highway Corridor (SHC) program and the North Carolina Intrastate System, while maintaining access to properties along existing U.S. 74.
