Subject:	Internal/External Scoping Meeting for SR 1860 (Macy Grove Road). Convert Grade Separation to Interchange, Guilford County, WBS No. 46964.1.1, TIP No I-5980.

The Project Management Unit is starting the project development, environmental and engineering studies for the proposed conversion of SR 1860 (Macy Grove Road) grade separation over I-40 to an interchange. The project is included in the current NCDOT 10 Year Work Program. Right of way acquisition is scheduled for Fiscal Year 2024 and construction is scheduled for Fiscal Year 2026.

At this time, it is anticipated that a Categorical Exclusion (CE) will be prepared for this project. The project will likely require the following permits: (USACE Section 404 permit, NCDENR Section 401 Water Quality Certification, Coast Guard, etc.).

An Internal/External Scoping Meeting has been scheduled on May 17, 2018 at 10 am and will be held in the NCDOT Structure Design Conference Room C in the NCDOT Century Center Building A. Existing project data for your use in preparing for this meeting is located on SharePoint at:

### Initial Scoping Comments:

- There are two hospitals located east of the project (Kernersville VA Health Care Center and Novant Health Kernersville Medical Center).
- There are new apartments located north of the project (The Grove at Kernersville). A few years ago, Novant Health Kernersville Medical Center hired a consultant to prepare a conceptual design for a partial cloverleaf interchange to provide easier access to the hospital.
- Bridge No. 609 is located at the project site. The condition of the bridge could be a concern if traffic from the Business 40 widening and NC 66 is redirected across the bridge. The Division suggested the bridge may need to be widened to accommodate traffic during construction.
- The Division also noted a future widening project on NC 66. Projects, I-5981A & I-5981B are also adjacent projects scheduled for 2024 Right of Way and 2026 LET. Coordination is needed with Division 7 and Division 9 through the entire project.

Draft Project Need:

The need for this project is to convert a grade separation into an interchange.

The purpose of the project is to provide access for nearby hospitals from Macy Grove Road to I-40.
