Dear Madam:

Due to concerns expressed by adjacent affected landowners for this project, the NCDOT has reduced and shifted the footprint of the project to reduce impacts to the property of adjacent landowners. This shift places the bridge closer to the existing bridge, but in order to accommodate a larger turning radius, also impacts a UT to East Fork French Broad River.

A permit modification is hereby requested for two purposes:

1. This shift has resulted in a change to the drawings from what was previously provided in the original application, and has resulted in a change in impacts. Previously, the Department proposed a 76 foot long single span bridge resulting in 70 linear feet of bank stabilization and 60 linear feet of temporary impact for bridge removal.

The Department now proposes to use a 60 foot long single span bridge (a shorter span, due to a lesser skew) resulting in 90 linear feet of bank stabilization and <0.01 acre (20 linear feet) of temporary impact to accommodate the installation of the bank stabilization.



2. The previous permit (Regional General Permit No. 198200031) expired on October 31, 2013. Since there is no mechanism for renewal as of the date of this application, the NCDOT requests to modify the existing GP 31 to a Nationwide 13 and 33.

This project now calls for a letting date of April 15, 2014 and a review date of February 25, 2014.
