This letter is in response to the application you submitted to the U.S. Army Corps of Engineers (USACE), Wilmington District, WRDA/Transportation Branch on May 28, 2025, for a Department of the Army general permit verification to conduct surveys to design three bridges that will replace bridges that were damaged by Hurricane Helene. This work will occur at Bridge 135 on SR 1112, Bridge 180 on SR 1179, and Bridge 287 on SR 1183; all bridge sites are over the Cane River in Yancey County, North Carolina. The work for these three sites were submitted as one project and this project has been assigned file number SAW-2025-01105. In order to perform this work, NCDOT proposes to conduct the following activities in waters of the U.S.:











Figure 1 Vicinity Map

May, 2025

















Figure 1 Vicinity Map

Bridge 180 on SR 1179 (Powell Road) Burnsville, Yancey County, NC May, 2025












Figure 1 Vicinity Map
