Dear Mr. Hancock:


Please reference your December 5, 2013, request to modify the emergency Department of the Army Permit issued to you on December 5, 2013, to place, via pipe line dredge, 30,000 yds³ of sand adjacent to the Herbert C. Bonner Bridge at Bent #166, Oregon Inlet, Dare County, North Carolina.

It is our understanding that as part of this emergency repair to fortify Bent Number 166 it is essential to conduct sub-surface investigations to gather information for the foundation design, scour prediction purposes and current bridge foundation conditions. The information collected will be used to more accurately assess the capacity of the bridge foundation in determining the feasibility of re-opening the bridge. Specifically, the modification allows geotechnical investigations and the placement of test piles per the enclosed plans and the description in your December 6, 2013, request. All the activities described above will be conducted in the area depicted as "proposed disposal zone" on the enclosed drawings.

After review of your modification request it has been determined that the Wilmington District Corps of Engineers has no objection to your proposal. Accordingly, the permit is hereby modified in accordance with the specific work activities described above and the enclosed plans and modification letter. It is understood that all other conditions of your permit remain in full force and effect including an expiration date of, May 15, 2014.

If the permitted work is not completed on or before the date herein specified, the authorization, if not previously revoked or specifically further extended, will cease and become null and void.

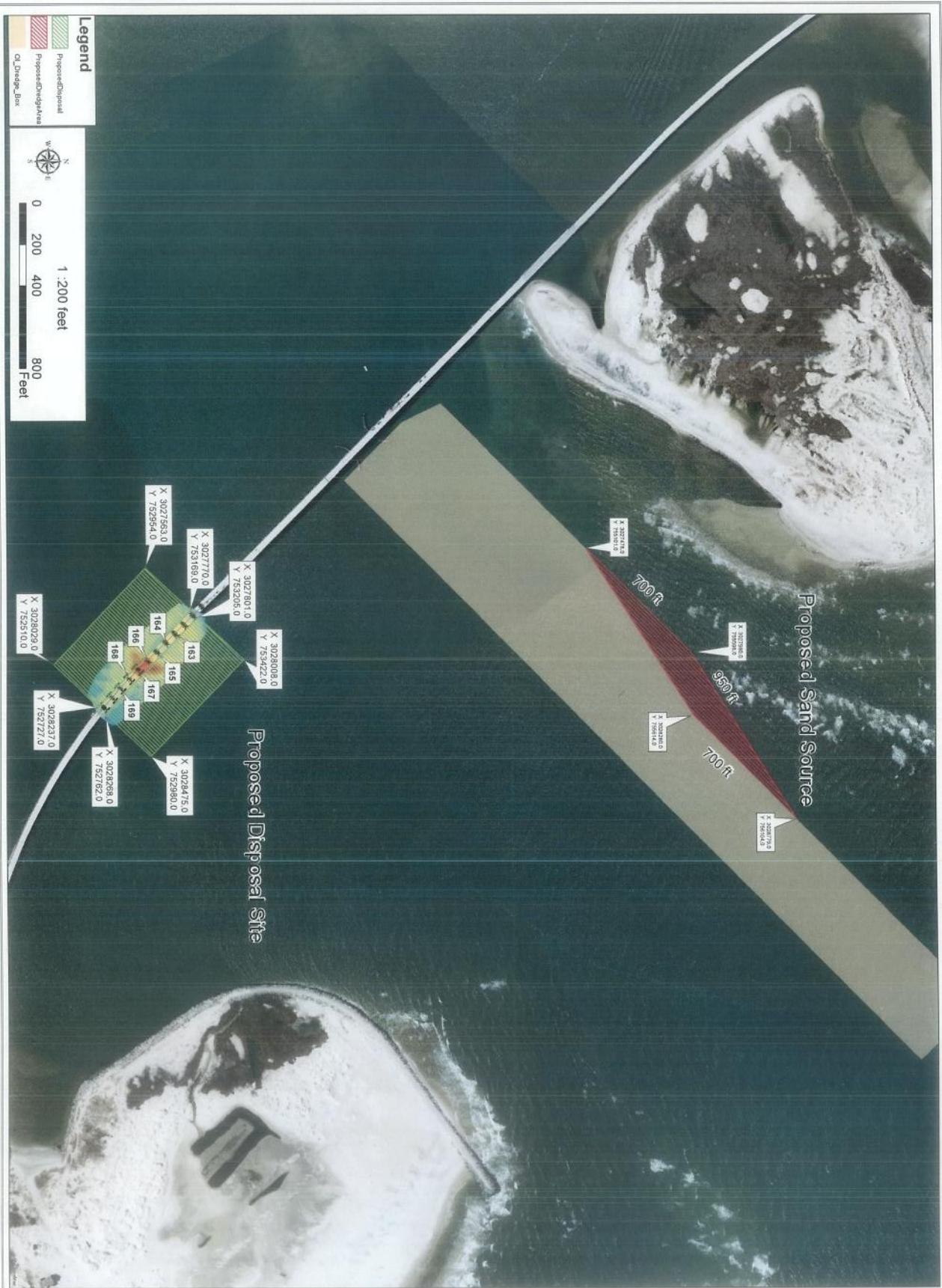
